

Information on data protection for TIB Open Publishing

The Technische Informationsbibliothek (TIB), public foundation founded in accordance with the laws of Lower Saxony¹, operates a platform aimed at scholars who want to share, explore and reuse research datasets in a novel manner called Leibniz Data Manager (LDM). In order to be able to provide the publishing services of TIB-LDM, TIB must collect and store your personal data.

TIB processes the following data of all customers of TIB LDM

Datasets' managers/editors:

- Contact data (first name and surname)
- Personal Email
- Organization affiliation (optional)
- Group affiliation (optional)

Authors of datasets:

- Title of the dataset
- Description of the dataset
- Resources (data in different formats: csv, json, xml, etc.)
- Names of the authors
- ORCID of the authors
- Personal email of the authors (optional)

Maintainer of datasets:

- Contact data (first name and surname)
- Personal email (optional)

TIB uses the information you enter, namely your name and email address internally, but also to

- Contact you and notify you about changes to the Leibniz Data Manager ...
- Credit you for publications This information will be anonymized upon request of deletion of your personal data in the Leibniz Data Manager.
- Share metadata about you as author with DataCite e.V. upon DOI-based publication of datasets.

The data will be stored for the duration of your use of the services of TIB LDM and will only be used for the purposes specified here. If you no longer wish to use the services provided by the platform of TIB LDM and TIB has no further claims against you or any other legal reason, we will delete your user account upon request. The personal data of authors or editors will be stored for the duration of the publication agreement.
